



## Non-Secure Detention

Non-Secure Detention (NSD) Services prevent youth, awaiting due process in Family Court, from committing further status offenses, or acts which if committed by an adult, would constitute a crime. NSD provides a structured staff-secure environment. Youth reside in the facility while awaiting disposition from Family Court.

## ABOUT THE SERVICE

### ABOUT THE SERVICE

Non-Secure Detention Services provide short-term care in an unlocked setting. During their stay in one of Hillside's detention facilities youth receive necessary medical care, including psychiatric consultation. They also participate in a variety of educational and recreational activities. Program Staff and Case Managers work closely with Family Court Judges, Probation Officers, staff from local Departments of Social Services, Law Guardians, and families on service planning and coordinating any needed services.

Youth in Non-Secure Detention are maintained in one of two co-ed settings: a) Northaven is a 12-bed facility serving youth from Monroe County; b) the Ontario County Youth Care Facility (Hopewell) is an 8-bed facility serving youth from Ontario and Wayne Counties. Other counties may be served on a space available basis. Youth residing in the co-educational group care facilities receive ongoing counseling, attend classes, and participate in daily recreational activities.

The following youth ages 9-18 are eligible for services:

- Persons in Need of Supervision (PINS) and Juvenile Delinquents (JDs) awaiting disposition of a court hearing;
- Adjudicated PINS and JDs awaiting disposition or transfer to a long-term facility;
- Youth who have violated conditions of release from a school district or the Office of Children and Family Services and need care away from their home.

Detention care is provided when there is a substantial probability that the youth will not appear in court when scheduled or, if before returning to court, that youth may commit an act that would, if committed by an adult, constitute a crime.

Referrals: Referrals to Non-Secure Detention Services are made through the Department of Probation and youth are subsequently remanded to the facilities by Family Court Judges.
